

Navy's Environmental Restoration Program





- Conducted under Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) – AKA "Federal Cleanup Law"
- Interim response actions can occur any time in the CERCLA process
- PFAS on-Base investigations are in the Remedial Investigation phase
- CERCLA process can last decades depending on site complexity
- Public forum via our Restoration Advisory Board next meeting fall 2022



On-Base PFAS Investigations



- Site Inspections complete at Ault Field, OLF Coupeville, and Seaplane Base
- Remedial Investigations (RIs) in progress:
 - OLF Coupeville
 - Ault Field Former Runway Fire School, Former Area 6 Landfill, & Current Fire Training Area
- Upcoming RIs:
 - Ault Field Airfield, Former Sewage Lagoons, & Former Wastewater Treatment Plant
 - Seaplane Base Biosolids Area & Building 18






Off-Base PFAS Drinking Water Response Actions – Oak Harbor



- 170 drinking water wells sampled todate
- 8 drinking water wells exceed 2016 EPA lifetime health advisory associated with 26 homes
- Connected one resident to a new, deeper well and one resident to public water system in November 2021
- Connected 24 homes to City of Oak Harbor waterline in June 2022
- Conduct biannual sampling

Off-Base PFAS Drinking Water Response Actions – Coupeville



- 117 drinking water wells sampled todate
- 8 drinking water wells exceed 2016
 EPA lifetime health advisory associated with 11 homes
- Town of Coupeville and Navy have a two Cooperative Agreements in support of the long-term solution to address PFAS in drinking water
- 7 of 11 impacted homes connected in March 2020
- Completed PFAS upgrades to the Town's water plant in Jan 2021
- Plan to complete final new waterlines in summer 2023
- Conduct biannual sampling
