News from Whidbey Island Water Systems Association Annual Meeting Recap

Thank you to all who attended the 2023 annual meeting in December. We had a great turn out for the Zoom meeting with **51 total participants** including voting members, guests and presenters.

The Apprenticeship program scholarship was extended to two years, covering the full tuition needed for participants to complete training for their WDM II OIT certification. We had an update on the two participants currently attending ERWOW's Apprenticeship program through the benefit of the WIWSA scholarship.

Chris Kelley, the Island County Hydrogeologist, presented a timeline of the county's hydrogeological database concluding with a presentation of the latest toolset. You can go to the Island County Hydrogeology Dashboard to lookup the latest well information. It's a work in progress as Chris will be continuing to update the data and enhance the features of the tools as time and staffing permit. PFAS News & Events

The Navy announced that they are hosting two Open House Public Meetings on February 1st, 2024, at 12:30 pm - 2:30 pm and 5:00 pm - 7:00 pm, both held at the Elks Lodge, 155 NE Ernst St, Oak Harbor, WA 98277 to provide information to the public about the Navy's offer to sample drinking water wells near Naval Air Station Whidbey Island. The Open House Public Meetings will have detailed information about the proposed drinking water sampling near Area 6 Landfill. The sampling is for certain per- and polyfluoroalkyl substances (PFAS), which may be present in these drinking water wells due to past use of firefighting foam or other PFAS- containing materials on base.

Property owners who drink water from a well on a property located within the sampling area may request sampling at either the open house, by calling 1-844-WHI-PFAS (1-844-944-7327) and leaving a message, or by sending an email to naswi.pfas@iacobs.com.

News from our Partners

Island County 2025 Comprehensive Plan Public Meetings Scheduled

Island County is conducting a periodic update to its comprehensive plan, due by June 30, 2025. Several elements within the planning will affect water systems including Natural Resource, Utilities and Climate Resilience which address water supply and availability, aquifer recharge, saltwater intrusion and watershed management among others.

Department of Ecology on December 20th published a draft Environmental Impact Statement (EIS) about the collection and disposal of aqueous film- forming foam (AFFF), used by municipal fire departments to extinguish liquid fuel-based fires. They are accepting comments through February 5, 2024.

DOE will hold both an information session where you can learn more about the draft EIS through a presentation by Ecology staff and a public hearing where you can submit formal public comments verbally and in writing.

- Draft EIS public hearing: Jan 31, 2024 from 1 pm to 4 pm Zoom

The **DOH Office of Drinking Water** released information about some important loan and grant programs available this year along with Emergency Rule changes that went into effect on December 29, 2023. The application windows for the announced programs are either open immediately or within the next month. For more details you can find the full ODW release <u>here</u>.

Lead Service Line Loan — Intended for any LSL inventory or replacement projects.

- Application cycle opened January 8, 2024.
- · Applications due by 11:59 p.m. PDT on March 29, 2024.

Consolidation Feasibility Study Grant Application Cycle — To support consolidation of small water systems into larger entities with greater technical, managerial, and financial capacity including consolidation of Group B and private wells into a new or existing Group A water system.

- Opens February 1, 2024.
- · Applications accepted year-round.

Planning and Engineering Loan Application Changes (Previously Called the Preconstruction Loan) — Updates include funding up to \$200,000 for limited water rights exploration.

- · Application window currently open.
- · Applications accepted year-round.

Drinking Water Systems Rehabilitation and Consolidation Grant – Funding may be used for consolidation, restructuring, or receivership of a failing system or the rehabilitation of a struggling system.

Find guidance on how projects are selected, who are eligible applicants, and what information you must submit in <u>Drinking Water System Rehabilitation and Consolidation Guidance 331-742</u>.

Emergency Rule Changes — The emergency adoption allows forgiveness of a portion or all of the SRF loan amount, update the definition of a disadvantaged community, removes water system plan requirements for those systems that are seeking a loan to address LSL identification and replacement, and remove obsolete priority rating and ranking criteria to allow more water systems to qualify for loans in conformance.

- Effective date December 29, 2023.
- Expiration date April 26, 2024.
