- The members passed the 2021 budget, including a sum for the apprenticeship/scholarship program.

- In January we held a special member meeting to <u>comment</u> on the Office of Drinking Water's draft rule changes around PFAS.
- In February Randi Perry and John Lovie presented What are you Drinking? at Sound Waters University.
- Jim Patton stepped down as president and John Lovie stepped up from Vice President
- Due to COVID, our member meetings moved to zoom. We are looking to improve member participation in future meetings.
- We started this monthly newsletter to keep the membership informed.
- We reviewed our work on the Small Water Systems Management Program. Asset Management was identified as the area where we were struggling Two member meetings and additional training sessions were held.
- We continued to work closely with AWWA, ERWoW, RCAC, the Office of Drinking Water, and Island County Public Health
- We partnered with ERWoW and RCAC to develop an apprenticeship/scholarship program

- The <u>Island County Planning Commission</u> held a public hearing on code changes around Accessory Dwelling Units (ADUs). The Planning Commission referred the proposed changes back to staff for further work. Most of the concerns were around drinking water impacts. John Lovie, Joe Grogan, and Randi Perry attended a workshop with Island County staff to further discuss the drinking water issues. We will continue to monitor these developments.
